***Return Construction Inspection Fee:**

Fees apply when contractors are not ready for scheduled appointment or when contractor is not onsite without calling to reschedule prior to appointment time. Fee doesn't apply when return visits are necessary for safety issues. Contractors will be given one "free" return visit. A second offense will trigger the fee and contractor will not be able to schedule another inspection until the fee is paid in full.
